## 1. Agenda

The draft agenda was approved for the meeting. Apologies for absence were noted as above.

# 2. Approval of minutes of the General Assembly 04\_04\_2017

The minutes were approved.

#### 3. Update on social dialogue activities

The test phase (ESSDC) continued by EASE & UNI-Europa with EuropeActive and EC-OE as observers ended in 2017.

The final report for the social dialogue project involving fitness and outdoor sectors holding roundtables between employers was submitted in September by UNI-Europa.

A project under Erasmus+ Key Action 2 was approved by DG EMPL in 2016 and as part of its objectives a new Sector Skills Alliance for Active Leisure (SSA) was formed in November 2016. The SSA concept had been presented to the EQF Advisory Group in October 2017.

Social dialogue and the engagement of both employers and employees is considered an important principle of how the SSA will develop. The problem remains that the European Association of Sport Employers (EASE) considers itself to be the "representative" body for social dialogue at the European

level. EuropeActive and the European Confederation of Outdoor Employers (EC-OE) have made a proposal for future cooperation, but this has been rejected by EASE.

EuropeActive and EC-OE have directly approach the European Commission to ask for their formal recognition as representative employer organisations as identified in the Eurofound Study of 2013.

# 4. Resolution for continued action in social dialogue and to form a sector skills alliance

The members agree that EHFA-E, in cooperation with EuropeActive, and through the recognition given to it in the Eurofound Study (2013), should continue to promote its representative position for employers in the fitness sector at the European level.

This will involve cooperating with other stakeholders and representative organisations and European Union Institutions, as considered appropriate, to promote and protect the fitness sector in the area of social dialogue and for the continued development of the sector skills alliance for active leisure (with the outdoor sector) that was launched in November 2016.

The resolution was passed unanimously.

## 5. Any other business

The Members expressed their support to the expansion of EHFA-E membership.

## **Next Meeting:**

The next meeting is scheduled for April 2019, to follow EuropeActive's General Assembly.
